## Leave An Enduring Impact

Many of us feel a compelling need to make a difference—to leave a lasting impact on the people and organizations that mean the most to us. A [bequest](#) is the easiest, most tangible, and flexible way to leave a legacy of enduring significance.

### **BENEFITS OF MAKING A BEQUEST**

- You leave a lasting legacy.
- You can lessen the burden of taxes on your estate, resulting in a larger inheritance for your heirs.

- You can choose to designate that a bequest be used for a general or specific purpose, so you have peace of mind knowing that your gift will be used as intended.
- You can continue to use property you will leave to charity during your life.
- A bequest is generally a revocable gift, meaning it can be changed or modified at any time.

## **AN EASY GIFT TO MAKE**

A [bequest](#) is one of the easiest ways to give. With the help of an adviser, you can include language in your will or trust specifying a gift be made to family, friends, or Bethel University as part of your estate plan. You can make a bequest in a number of ways:

**Specific Bequest.** Make a gift of a specific asset such as real estate, a car, other property, or a gift of a specific dollar amount.

**Percentage Bequest.** Leave a specific percentage of your overall estate to Bethel University.

**Residual Bequest.** Make a gift from the balance of an estate after the will or trust has given away each of the specific bequests. A common residual bequest involves leaving a percentage of the residue of the estate to charity.

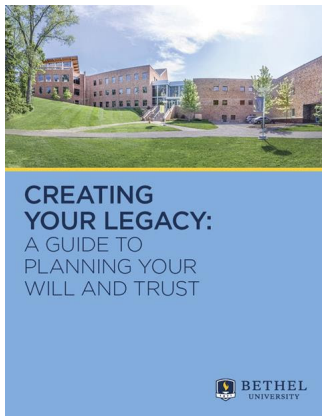
